
2 Connecting the Keyboard

Un-install any previous keyboard software to ensure best success.

To lengthen your keyboard cable, connect the cable extension provided in the kit.


Connecting to PS2

1. Turn off the computer system.
2. Connect the keyboard cable with the PS2 connector into the PS2 connector on the rear of the computer.



Connecting to USB

1. Leave the computer system on or off.
2. Remove the PS2 adapter, if necessary, from the connector end of the keyboard cable, and then plug the USB connector into a USB connector on the computer.



3 Maintenance and Cleaning

The following solvents can be used to wash the keyboard:

- Soap
- Washing-up liquid
- Non-abrasive cleaners
- General purpose cleaners
- Bleach
- Disinfectant
- Antibacterial cleaners
- Surgical spirit

 **NOTE:** Observe the manufacturers instructions for the preparation and use of all cleaning fluids and wear the appropriate protective clothing.

Washing the Keyboard

To protect against the build-up of dust and dirt, routinely wash the keyboard.

1. Unplug the keyboard from the computer and remove the extension cable and USB-to-PS2 adapter, if installed.
2. Wash the keyboard under running water up to a maximum of 80° Celsius / 176° Fahrenheit.
3. If the USB plug (connector) gets wet, shake dry before reconnecting.



4. Shake vigorously to drain excess liquid from the keyboard and wipe dry.



To thoroughly clean the keyboard:

1. Unplug the keyboard from the computer and remove the extension cable and USB-to-PS2 adapter, if installed.
2. Fill a washbasin or similar container with a cleaning solution.
3. Place the keyboard in the solution and actively agitate it around so that the liquid reaches every recess on all surfaces.

 **NOTE:** The process of agitated soaking should require no more than 30 seconds to be effective.

4. Leave the keyboard in the solution for approximately 60 seconds.
5. Remove the keyboard and rinse under running water.
6. Shake vigorously to drain excess liquid and wipe dry.
7. If the USB plug (connector) gets wet, shake dry before reconnecting.

 **NOTE:** Excess water or liquids may remain in the keyboard's switch areas. To remove the excess water, turn the keyboard over, keys side down, or position it sideways and let the water thoroughly drain from the keyboard.

Water and Dust Protection

The HP washable keyboard provides protection against ingress of water and dust to code IP66 defined in IEC (International Electro Technical Commission) standard 60529-1 and code 4X as defined in NEMA (National Electrical Manufacturers Association) standard 250.

The code IP66 defined in the IEC standard 60529 means the keyboard is protected against the ingress of dust, and that high pressure water jets from any direction will not have any harmful effects. A NEMA 4X enclosure as defined in NEMA standard 250 will provide protection against windblown dust, rain, splashing water and hose directed water.

A Troubleshooting

Solving Common Problems

Problem	Possible Cause	Solution
Keyboard commands and typing are not recognized by the computer.	Keyboard connector is not properly connected.	<p>Shut down the computer using the operating system.</p> <p>After the shutdown is complete, reconnect the keyboard to the computer and restart the computer.</p>
When typing, letters repeat even though you do not hold the key down for very long.	Windows keyboard setting.	<ol style="list-style-type: none">1. Click on Start > Control Panel.2. Select Keyboard > Speed tab.3. Then adjust the Repeat Delay. On most computers, placing the slider at one mark from the Short side is ideal.
Keys are stiff.	Build-up of spray solution.	Using a spray solution on the keyboard will leave a residue, which if allowed to build up, will cause the keys to become stiff. The keyboard should be rinsed thoroughly whenever the keys show signs of becoming stiff.
After plugging in the USB Keyboard the cursor will not move and / or the Keyboard will not function.	USB is not detected.	<p>Plug the keyboard into a different USB port.</p> <p>Try the keyboard in another system if possible.</p> <p>If you have another USB device try using that in the USB port to see if it works as the port or keyboard may be faulty.</p> <p>If you are using a USB hub, docking station, switch box, port replicator or extension cable to connect to the keyboard, try removing and plugging the keyboard directly into the system.</p>
Cleaning solution leaves a residue on keys.	Using cleaning sprays.	Any cleaning spray can be used but it is strongly recommended that you wash the keyboard as well. The cleaning solution can leave a residue behind, which can build up over time and effect the operation of the keyboard.

Problem	Possible Cause	Solution
Gel-based cleaning solution leaves gel deposits on keyboard.	Gel-based solution does not fully dissolve in water.	Gel-based sterilizing solutions are not suitable for cleaning the keyboard. The solution allows the possibility of gel deposits to form due to the fact that the gel has not been fully removed during the wash process. This can lead to poor hygiene and have an effect on the performance of the keyboard.
While washing the keyboard the USB connector got wet.	Water is trapped by the connector.	Shake dry the connector and any water that is trapped will be removed. It is now safe to reconnect the plug back into the computer.
Sodium Hypochlorite (NaOCl), which is used in most bleaches and cleaning agents, may damage the keyboard.	Harsh cleaning products.	Sodium Hypochlorite is normally dangerous to use above 15% solution. A solution of this chemical at this level does no damage to the keyboard.
