






Before You Begin

Before assembling the HP Retail Mobile POS Case, consult the readme documentation included with the MSR and barcode scanner drivers. Drivers may be included on a CD that came with the case or they can be downloaded from <u>www.hp.com</u>.

- 1. Go to <u>www.hp.com</u>.

- 3. Click the Drivers & Software link.
- 4. In the SEARCH box, enter HP Slate 2 Tablet PC and click the **SEARCH** button.
- 5. Follow the on-screen instructions.


Before assembling the HP Retail Mobile POS Case be sure to power off the computer.
