Drive configuration may vary by model. Some models have a bezel blank covering the slim optical drive bay.





When a graphics card is installed in one of the system board slots, the video connectors on the graphics card and/or the integrated graphics on the system board may be used. The specific graphics card installed and software configuration will determine the behavior.

The system board graphics can be disabled by changing settings in BIOS F10 Setup.

Serial number location

Each computer has a unique serial number and a product ID number that are located on the exterior of the computer. Keep these numbers available for use when contacting customer service for assistance.



2 Hardware upgrades

Serviceability features

The computer includes features that make it easy to upgrade and service. A Torx T15 or flat-bladed screwdriver is needed for some of the installation procedures described in this chapter.

Warnings and cautions

Before performing upgrades be sure to carefully read all of the applicable instructions, cautions, and warnings in this guide.

WARNING! To reduce the risk of personal injury from electrical shock, hot surfaces, or fire:

Disconnect the power cord from the AC outlet and allow the internal system components to cool before you touch them.

Do not plug telecommunications or telephone connectors into the network interface controller (NIC) receptacles.

Do not disable the power cord grounding plug. The grounding plug is an important safety feature.

Plug the power cord into a grounded (earthed) AC outlet that is easily accessible at all times.

When the computer is plugged into an AC power source, voltage is always applied to the system board. To prevent damage to internal components, you must disconnect the power cord from the power source before opening the computer.

Preparing for disassembly


- 1. Remove/disengage any security devices that prohibit opening the computer.
- **2.** Remove all removable media, such as compact discs or USB flash drives, from the computer.
- 3. Turn off the computer properly through the operating system, and then turn off any external devices.
- Disconnect the power cord from the power outlet and disconnect any external devices.

IMPORTANT: Regardless of the power-on state, voltage is always present on the system board as long as the system is plugged into an active AC outlet. You must disconnect the power cord to avoid damage to the internal components of the computer.

Removing the computer access panel


To access internal components, you must remove the access panel.

- 1. Prepare the computer for disassembly. See <u>Preparing for disassembly on page 4</u>.
- 2. If the computer is on a stand, remove the computer from the stand and lay the computer down.
- 3. Slide the access panel release lever (1) to the left so that it locks into place. Then slide the access panel (2) back and lift it off the computer (3).




Replacing the computer access panel

Be sure that the access panel release lever is locked into place, and then place the access panel on the computer (1) and slide the panel (2) forward. The release lever will automatically move back to the right and lock the access panel.



Removing the front bezel


- 1. Prepare the computer for disassembly. See <u>Preparing for disassembly on page 4</u>.
- 2. Remove the computer access panel. See <u>Removing the computer access panel on page 5</u>.
- 3. Lift up the three tabs on the top of the bezel (1), and then rotate the bezel off the chassis (2).



Removing a slim optical drive bezel blank


On some models, a bezel blank covers the slim optical drive bay. Remove the bezel blank before installing an optical drive. To remove the bezel blank:

- 1. Prepare the computer for disassembly. See <u>Preparing for disassembly on page 4</u>.
- 2. Remove the computer access panel. See Removing the computer access panel on page 5.
- 3. Remove the front bezel. See Removing the front bezel on page 7.
- 4. Press inward on the tab on the right side of the blank (1), and then rotate the blank off the front bezel (2).



Replacing the front bezel

Insert the three hooks on the bottom of the bezel (1) into the rectangular holes on the chassis, and then rotate the top of the bezel onto the chassis (2) and snap it into place.




Removing and installing the optional front bezel dust filter

Some models are equipped with an optional front bezel dust filter. You must periodically clean the dust filter so that the dust collected on the filter does not impede air flow through the computer.

NOTE: The optional front bezel dust filter is available from HP.


To remove, clean, and replace the dust filter:

- Prepare the computer for disassembly. See Preparing for disassembly on page 4.
- Remove the computer access panel. See Removing the computer access panel on page 5.
- 3. Remove the front bezel. See Removing the front bezel on page 7.
- To remove the dust filter, use your fingers to separate the filter from the front bezel at the tab locations shown below.



Use a soft brush or cloth to clean dust from the filter. If heavily soiled, rinse the filter clean with water.

To replace the dust filter, press the filter firmly onto the front bezel at the tab locations shown below.



Reconnect the power cord and any external devices, and then turn on the computer. **7.**

Changing from desktop to tower orientation

The Small Form Factor computer can be used in a tower orientation with an optional tower stand that can be purchased from HP.

- NOTE: To stabilize the computer in a tower orientation, HP recommends the use of the optional tower stand.
 - 1. Prepare the computer for disassembly. See <u>Preparing for disassembly on page 4</u>.
 - 2. Orient the computer so that its right side is facing up and place the computer in the optional stand.



- 3. Reconnect the power cord and any external devices, and then turn on the computer.
- NOTE: Be sure that at least 10.2 centimeters (4 inches) of space on all sides of the computer remains clear and free of obstructions.
- 4. Lock any security devices that were disengaged before the computer was moved.



Upgrading system memory

The computer comes with double data rate 4 synchronous dynamic random access memory (DDR4-SDRAM) dual inline memory modules (DIMMs).

The memory sockets on the system board are populated with at least one preinstalled memory module. To achieve the maximum memory support, you can populate the system board with up to 128 GB of memory configured in a high-performing dual-channel mode. The maximum single-module memory capacity is 32 GB.

For proper system operation, the DIMMs must adhere to the following specifications:

- Industry-standard 288-pin
- Unbuffered non-ECC PC4-21300 DDR4-2666 MHz-compliant
- 1.2 volt DDR4-SDRAM memory modules
- CAS latency 19 DDR4 2666 MHz
- Mandatory JEDEC SPD information

The computer supports the following:

- 512 Mb, 1 Gb, 2 Gb, 4 Gb, 8 Gb, and 16 Gb non-ECC memory technologies
- Single-sided and double-sided memory modules
- Memory modules constructed with ×8 and ×16 DDR devices; memory modules constructed with ×4 SDRAM are not supported



Installing a memory module

There are four memory sockets on the system board, with two sockets per channel. The sockets are labeled DIMM1, DIMM2, DIMM3, and DIMM4. Sockets DIMM1 and DIMM2 operate in memory channel B. Sockets DIMM3 and DIMM4 operate in memory channel A.

The system will automatically operate in single-channel mode, dual-channel mode, or flex mode, depending on how the DIMMs are installed.



- The system will operate in single-channel mode if the DIMM sockets are populated in one channel only.
- The system will operate in a higher-performing dual-channel mode if the total memory capacity of the DIMMs in Channel A is equal to the total memory capacity of the DIMMs in Channel B. The technology and device width can vary between the channels. For example, if Channel A is populated with two 1 GB DIMMs and Channel B is populated with one 2 GB DIMM, the system will operate in dual-channel mode.
- NOTE: When using two memory modules, both DIMM memory module part numbers must be identical to set memory speed to max performance mode (2666MHz).
- The system will operate in flex mode if the total memory capacity of the DIMMs in Channel A is not equal to the total memory capacity of the DIMMs in Channel B. In flex mode, the channel populated with the least amount of memory describes the total amount of memory assigned to dual channel and the remainder is assigned to single channel. For optimal speed, the channels should be balanced so that the largest amount of memory is spread between the two channels. If one channel will have more memory than the other, the larger amount should be assigned to Channel A. For example, if you are populating the sockets with one 2 GB DIMM, and three 1 GB DIMMs, Channel A should be populated with the 2 GB

DIMM and one 1 GB DIMM, and Channel B should be populated with the other two 1 GB DIMMs. With this configuration, 4 GB will run as dual-channel and 1 GB will run as single-channel.

- In any mode, the maximum operational speed is determined by the slowest DIMM in the system.
- IMPORTANT: You must disconnect the power cord and wait approximately 30 seconds for the power to drain before adding or removing memory modules. Regardless of the power-on state, voltage is always supplied to the memory modules as long as the computer is plugged into an active AC outlet. Adding or removing memory modules while voltage is present may cause irreparable damage to the memory modules or system board.


The memory module sockets have gold-plated metal contacts. When upgrading the memory, it is important to use memory modules with gold-plated metal contacts to prevent corrosion and/or oxidation resulting from having incompatible metals in contact with each other.

Static electricity can damage the electronic components of the computer or optional cards. Before beginning these procedures, ensure that you are discharged of static electricity by briefly touching a grounded metal object. For more information, refer to Electrostatic Discharge on page 50.

When handling a memory module, be careful not to touch any of the contacts. Doing so may damage the module.

- 1. Prepare the computer for disassembly. See <u>Preparing for disassembly on page 4</u>.
 - IMPORTANT: You must disconnect the power cord and wait approximately 30 seconds for the power to drain before adding or removing memory modules. Regardless of the power-on state, voltage is always supplied to the memory modules as long as the computer is plugged into an active AC outlet. Adding or removing memory modules while voltage is present may cause irreparable damage to the memory modules or system board.
- 2. Remove the computer access panel. See Removing the computer access panel on page 5.
 - **WARNING!** To reduce risk of personal injury from hot surfaces, allow the internal system components to cool before you touch them.

Open both latches (1) of the memory module socket, and insert the memory module into the socket (2).
 Press the module down into the socket, ensuring that the module is fully inserted and properly seated.
 Make sure the latches are in the closed position (3).



NOTE: A memory module can be installed in only one way. Match the notch on the module with the tab on the memory socket.

Populate the black DIMM sockets before the white DIMM sockets.

For maximum performance, populate the sockets so that the memory capacity is spread as equally as possible between Channel A and Channel B.

- 4. Repeat step 3 to install any additional modules.
- Replace the computer access panel.
- **6.** If the computer was on a stand, replace the stand.
- **7.** Reconnect the power cord and any external devices, and then turn on the computer. The computer should automatically recognize the additional memory.
- **8.** Lock any security devices that were disengaged when the access panel was removed.

Removing or installing an expansion card

The computer has two PCI Express ×1 expansion sockets, one PCI Express ×16 expansion socket, and one PCI Express ×16 expansion socket that is downshifted to a ×4 socket.


NOTE: The PCI Express sockets support only low profile cards.

You can install a PCI Express ×1, ×4, ×8, or ×16 expansion card in the PCI Express ×16 socket.


For dual graphics card configurations, the first (primary) card must be installed in the PCI Express ×16 socket that is NOT downshifted to a ×4.

To remove, replace, or add an expansion card:


- 1. Prepare the computer for disassembly. See Preparing for disassembly on page 4.
- 2. If the computer is on a stand, remove the computer from the stand.
- 3. Remove the computer access panel. See Removing the computer access panel on page 5.
- **4.** Locate the correct vacant expansion socket on the system board and the corresponding expansion slot on the back of the computer chassis.
- 5. Release the slot cover retention latch that secures the slot covers by lifting the tab on the latch and rotating the latch to the open position.




- 6. Before installing an expansion card, remove the expansion slot cover or the existing expansion card.
 - NOTE: Before removing an installed expansion card, disconnect any cables that may be attached to the expansion card.
 - a. If you are installing an expansion card in a vacant socket, remove the appropriate expansion slot cover on the back of the chassis. Pull the slot cover straight up then away from the inside of the chassis.



b. If you are removing a PCI Express ×1 card, hold the card at each end and carefully rock it back and forth until the connectors pull free from the socket. Lift the card (1) straight up then away from the inside of the chassis (2) to remove it. Be sure not to scrape the card against other components.




c. If you are removing a PCI Express ×16 card, pull the retention arm on the back of the expansion socket away from the card (1) and carefully rock the card back and forth until the connectors pull free from the socket. Lift the card (2) straight up then away from the inside of the chassis (3) to remove it. Be sure not to scrape the card against other components.




- 7. Store the removed card in anti-static packaging.
- 8. If you are not installing a new expansion card, install an expansion slot cover to close the open slot.

CAUTION: After removing an expansion card, you must replace it with a new card or expansion slot cover for proper cooling of internal components during operation.

9. To install a new expansion card, hold the card just above the expansion socket on the system board then move the card toward the rear of the chassis (1) so that the bottom of the bracket on the card slides into the small slot on the chassis. Press the card straight down into the expansion socket on the system board (2).



- NOTE: When installing an expansion card, press firmly on the card so that the whole connector is seated properly in the expansion card socket.
- **10.** Rotate the slot cover retention latch back in place to secure the expansion card.



11. Connect external cables to the installed card, if needed. Connect internal cables to the system board, if needed.

- **12.** Replace the computer access panel.
- **13.** If the computer was on a stand, replace the stand.
- **14.** Reconnect the power cord and any external devices, and then turn on the computer.
- **15.** Lock any security devices that were disengaged when the access panel was removed.
- **16.** Reconfigure the computer, if necessary.



Removing and installing drives

When installing drives, follow these guidelines:

- The primary Serial ATA (SATA) hard drive must be connected to the dark-blue primary SATA connector on the system board labeled SATAO.
- Connect secondary hard drives and optical drives to one of the light-blue SATA connectors on the system board labeled SATA1 and SATA2.

IMPORTANT: To prevent loss of work and damage to the computer or drive:

If you are inserting or removing a drive, shut down the operating system properly, turn off the computer, and unplug the power cord. Do not remove a drive while the computer is on or in standby mode.

Before handling a drive, be sure that you are discharged of static electricity. While handling a drive, avoid touching the connector. For more information about preventing electrostatic damage, refer to <u>Electrostatic</u> <u>Discharge on page 50</u>.

Handle a drive carefully; do not drop it.


Do not use excessive force when inserting a drive.

Avoid exposing a hard drive to liquids, temperature extremes, or products that have magnetic fields such as monitors or speakers.


If a drive must be mailed, place the drive in a bubble-pack mailer or other protective packaging and label the package "Fragile: Handle With Care."

Removing a 9.5 mm slim optical drive

- 1. Prepare the computer for disassembly. See <u>Preparing for disassembly on page 4</u>.
- 2. If the computer is on a stand, remove the computer from the stand.
- 3. Remove the computer access panel. See <u>Removing the computer access panel on page 5</u>.
- 4. Disconnect the power cable (1) and data cable (2) from the rear of the optical drive.
- **IMPORTANT:** When removing the cables, pull the tab or connector instead of the cable itself to avoid damaging the cable.



5. Push the green release latch on the right rear side of the drive toward the center of the drive (1), and then slide the drive forward and out of the bay (2).




Installing a 9.5 mm slim optical drive

- 1. Prepare the computer for disassembly. See <u>Preparing for disassembly on page 4</u>.
- 2. If the computer is on a stand, remove the computer from the stand.
- 3. Remove the computer access panel. See <u>Removing the computer access panel on page 5</u>.
- **4.** If you are installing a slim optical drive in a bay covered by a bezel blank, remove the front bezel and then remove the bezel blank. See Removing a slim optical drive bezel blank on page 8 for more information.
- 5. Align the small pin on the release latch with the small hole on the side of the drive and press the latch firmly onto the drive.



6. Slide the optical drive through the front bezel all the way into the bay (1) so that the latch on the rear of the drive locks into place (2).



7. Connect the power cable (1) and data cable (2) to the rear of the drive.



- 8. Connect the opposite end of the data cable to one of the light-blue SATA connectors on the system board labeled SATA1 or SATA2.
- **NOTE:** Refer to <u>System board connectors on page 13</u> for an illustration of the system board drive connectors.
- 9. Replace the front bezel if it was removed.
- **10.** Replace the computer access panel.
- **11.** If the computer was on a stand, replace the stand.


- **12.** Reconnect the power cord and any external devices, and then turn on the computer.
- 13. Lock any security devices that were disengaged when the access panel was removed.

Removing a 3.5-inch hard drive


NOTE: Before you remove the old hard drive, be sure to back up the data from the old hard drive so that you can transfer the data to the new hard drive.

There are two 3.5-inch hard drive bays. The procedure for removing a 3.5-inch hard drive is the same for each drive bay.


- 1. Prepare the computer for disassembly. See <u>Preparing for disassembly on page 4</u>.
- 2. If the computer is on a stand, remove the computer from the stand.
- 3. Remove the computer access panel. See Removing the computer access panel on page 5.
- 4. Disconnect the power cable (1) and data cable (2) from the rear of the hard drive.



5. Pull the release lever next to the rear of the hard drive outward (1). While pulling the release lever out, lift the rear of the drive up (2), and then slide the front of the drive back and lift it out of the bay (3).



6. Remove the four mounting screws (two on each side) from the old drive. You will need these screws if you install a new drive.




Installing a 3.5-inch hard drive



 - Install mounting screws on the sides of the hard drive using standard 6-32 silver-and-blue mounting screws.
 - NOTE: If replacing a 3.5-inch hard drive, transfer the mounting screws from the old hard drive to the new hard drive.

If you are adding a second 3.5-inch hard drive, you can purchase extra mounting screws from HP.





A Battery replacement

The battery that comes with the computer provides power to the real-time clock. When replacing the battery, use a battery equivalent to the battery originally installed in the computer. The computer comes with a 3-volt lithium coin cell battery.

WARNING! The computer contains an internal lithium manganese dioxide battery. There is a risk of fire and burns if the battery is not handled properly. To reduce the risk of personal injury:

Do not attempt to recharge the battery.

Do not expose to temperatures higher than 60°C (140°F).

Do not disassemble, crush, puncture, short external contacts, or dispose of in fire or water.

Replace the battery only with the HP spare designated for this product.

IMPORTANT: Before replacing the battery, it is important to back up the computer CMOS settings. When the battery is removed or replaced, the CMOS settings will be cleared.

Static electricity can damage the electronic components of the computer or optional equipment. Before beginning these procedures, ensure that you are discharged of static electricity by briefly touching a grounded metal object.


NOTE: The lifetime of the lithium battery can be extended by plugging the computer into a live AC outlet. The lithium battery is only used when the computer is NOT connected to AC power.

HP encourages customers to recycle used electronic hardware, HP original print cartridges, and rechargeable batteries. For more information about recycling programs, go to http://www.hp.com/recycle.

- 2. If the computer is on a stand, remove the computer from the stand.

- 4. Locate the battery and battery holder on the system board.
- NOTE: On some computer models, it may be necessary to remove an internal component to gain access to the battery.
- 5. Depending on the type of battery holder on the system board, complete the following instructions to replace the battery.

Type 1

a. Lift the battery out of its holder.



b. Slide the replacement battery into position, positive side up. The battery holder automatically secures the battery in the proper position.

Type 2

a. To release the battery from its holder, squeeze the metal clamp that extends above one edge of the battery (1). When the battery pops up, lift it out (2).




b. To insert the new battery, slide one edge of the replacement battery under the holder's lip with the positive side up (1). Push the other edge down until the clamp snaps over the other edge of the battery (2).



Type 3

a. Pull back the clip (1) that is holding the battery in place, and remove the battery (2).



- **b.** Insert the new battery and position the clip back into place.
- NOTE: After the battery has been replaced, use the following steps to complete this procedure.
- 6. Replace the computer access panel.
- 7. If the computer was on a stand, replace the stand.

- 8. Reconnect the power cord and any external devices, and then turn on the computer.
- 9. Reset the date and time, your passwords, and any special system setups using Computer Setup.
- **10.** Lock any security devices that were disengaged when the computer access panel was removed.

B Electrostatic Discharge

Electrostatic discharge is the release of static electricity when two objects come into contact—for example, the shock you receive when you walk across the carpet and touch a metal door knob.

A discharge of static electricity from fingers or other electrostatic conductors may damage electronic components.

To prevent damage to the computer, damage to a drive, or loss of information, observe these precautions:

- If removal or installation instructions direct you to unplug the computer, first be sure that it is properly grounded.
- Keep components in their electrostatic-safe containers until you are ready to install them.
- Avoid touching pins, leads, and circuitry. Handle electronic components as little as possible.
- Use nonmagnetic tools.
- Before handling components, discharge static electricity by touching an unpainted metal surface.
- If you remove a component, place it in an electrostatic-safe container.

C Computer operating guidelines, routine care and shipping preparation

Computer operating guidelines and routine care

Follow these guidelines to properly set up and care for the computer and monitor:

- Keep the computer away from excessive moisture, direct sunlight, and extremes of heat and cold.
- Operate the computer on a sturdy, level surface. Leave a 10.2-cm (4-inch) clearance on all vented sides
 of the computer and above the monitor to permit the required airflow.
- Never restrict the airflow into the computer by blocking any vents or air intakes. Do not place the keyboard, with the keyboard feet down, directly against the front of the desktop unit as this also restricts airflow.
- Never operate the computer with the access panel or any of the expansion card slot covers removed.
- Do not stack computers on top of each other or place computers so near each other that they are subject to each other's re-circulated or preheated air.
- If the computer is to be operated within a separate enclosure, intake and exhaust ventilation must be provided on the enclosure, and the same operating guidelines listed above will still apply.
- Keep liquids away from the computer and keyboard.
- Never cover the ventilation slots on the monitor with any type of material.
- Install or enable power management functions of the operating system or other software, including sleep states.
- Turn off the computer before you do either of the following:
 - Wipe the exterior of the computer with a soft, damp cloth as needed. Using cleaning products may discolor or damage the finish.
 - Occasionally clean the air vents on all vented sides of the computer. Lint, dust, and other foreign
 matter can block the vents and limit the airflow.

Optical drive precautions

Be sure to observe the following guidelines while operating or cleaning the optical drive.

Operation

- Do not move the drive during operation. This may cause it to malfunction during reading.
- Avoid exposing the drive to sudden changes in temperature, as condensation may form inside the unit. If
 the temperature suddenly changes while the drive is on, wait at least one hour before you turn off the
 power. If you operate the unit immediately, it may malfunction while reading.
- Avoid placing the drive in a location that is subject to high humidity, extreme temperatures, mechanical vibration, or direct sunlight.

Cleaning

- Clean the panel and controls with a soft, dry cloth or a soft cloth lightly moistened with a mild detergent solution. Never spray cleaning fluids directly on the unit.
- Avoid using any type of solvent, such as alcohol or benzene, which may damage the finish.

Safety

If any object or liquid falls into the drive, immediately unplug the computer and have it checked by an authorized HP service provider.

Shipping preparation

Follow these suggestions when preparing to ship the computer:

- 1. Back up the hard drive files to an external storage device. Be sure that the backup media is not exposed to electrical or magnetic impulses while stored or in transit.
- NOTE: The hard drive locks automatically when the system power is turned off.
- Remove and store all removable media.
- 3. Turn off the computer and external devices.
- 4. Disconnect the power cord from the AC outlet, and then from the computer.
- 5. Disconnect the system components and external devices from their power sources, and then from the computer.
- NOTE: Be sure that all boards are seated properly and secured in the board slots before shipping the computer.
- **6.** Pack the system components and external devices in their original packing boxes or similar packaging with sufficient packing material to protect them.

Standards and legislation

Standards

Section 508 of the Federal Acquisition Regulation (FAR) standards was created by the US Access Board to address access to information and communication technology (ICT) for people with physical, sensory, or cognitive disabilities. The standards contain technical criteria specific to various types of technologies, as well as performance-based requirements which focus on functional capabilities of covered products. Specific criteria cover software applications and operating systems, web-based information and applications, computers, telecommunications products, video and multi-media, and self-contained closed products.

Mandate 376 - EN 301 549

The EN 301 549 standard was created by the European Union within Mandate 376 as the basis for an online toolkit for public procurement of ICT products. The standard specifies the functional accessibility requirements applicable to ICT products and services, together with a description of the test procedures and evaluation methodology for each accessibility requirement.

Web Content Accessibility Guidelines (WCAG)

Web Content Accessibility Guidelines (WCAG) from the W3C's Web Accessibility Initiative (WAI) helps web designers and developers create sites that better meet the needs of people with disabilities or age-related limitations. WCAG advances accessibility across the full range of web content (text, images, audio, and video) and web applications. WCAG can be precisely tested, is easy to understand and use, and allows web developers flexibility for innovation. WCAG 2.0 has also been approved as ISO/IEC 40500:2012..

WCAG specifically addresses barriers to accessing the web experienced by people with visual, auditory, physical, cognitive, and neurological disabilities, and by older web users with accessibility needs. WCAG 2.0 provides characteristics of accessible content:

- Perceivable (for instance, by addressing text alternatives for images, captions for audio, adaptability of presentation, and color contrast)
- Operable (by addressing keyboard access, color contrast, timing of input, seizure avoidance, and navigability)
- Understandable (by addressing readability, predictability, and input assistance)
- Robust (for instance, by addressing compatibility with assistive technologies)

United States

Section 508 of the Rehabilitation Act specifies that agencies must identify which standards apply to the procurement of ICT, perform market research to determine the availability of accessible products and services, and document the results of their market research. The U.S. Access Board is currently updating the Section 508 standards. This effort will address new technologies and other areas where the standards need to be modified. For more information, go to Section 508 Refresh.

Section 255 of the Telecommunications Act requires telecommunications products and services to be accessible to people with disabilities. FCC rules cover all hardware and software telephone network equipment and telecommunications equipment used in the home or office. Such equipment includes telephones, wireless handsets, fax machines, answering machines, and pagers. FCC rules also cover basic and special telecommunications services, including regular telephone calls, call waiting, speed dialing, call forwarding, computer-provided directory assistance, call monitoring, caller identification, call tracing, and repeat dialing, as well as voice mail and interactive voice response systems that provide callers with menus of choices. 21st Century Communications and Video Accessibility Act (CVAA)

The CVAA updates federal communications law to increase the access of persons with disabilities to modern communications, updating accessibility laws enacted in the 1980s and 1990s to include new digital, broadband, and mobile innovations. Regulations are enforced by the FCC and documented as 47 CFR Part 14 and Part 79.

Canada

The Accessibility for Ontarians with Disabilities Act was established to develop and implement accessibility standards to make goods, services, and facilities accessible to Ontarians with disabilities and to provide for the involvement of persons with disabilities in the development of the accessibility standards. The first standard of the AODA is the customer service standard; however, standards for transportation, employment, and information and communication are also being developed. The AODA applies to the Government of Ontario, the Legislative Assembly, every designated public sector organization, and to every other person or organization that provides goods, services, or facilities to the public or other third parties and that has at least one employee in Ontario; and accessibility measures must be implemented on or before January 1, 2025. Europe

EU Mandate 376 ETSI Technical Report ETSI DTR 102 612: "Human Factors (HF); European accessibility requirements for public procurement of products and services in the ICT domain (European Commission Mandate M 376, Phase 1)" has been released.

Background: The three European Standardization Organizations have set up two parallel project teams to carry out the work specified in the European Commission "Mandate 376 to CEN, CENELEC and ETSI, in Support of Accessibility Requirements for Public Procurement of Products and Services in the ICT Domain."

ETSI TC Human Factors Specialist Task Force 333 has developed ETSI DTR 102 612. Further details about the work performed by STF333 (e.g., Terms of Reference, specification of the detailed work tasks, time plan for the work, previous drafts, listing of comments received and means to contact the task force) can be found at the Special Task Force 333.

The parts relating to the assessment of suitable testing and conformity schemes were carried out by a parallel project, detailed in CEN BT/WG185/PT. For further information, go to the CEN project team website. The two projects are closely coordinated.
