Kit Contents

Your HP USB PC web camera kit contains:

- 1 HP USB PC web camera
- 2 HP USB PC camera bases
- 1 Software and Drivers CD-ROM
- 1 HP support part-number sticker
- 1 *Installation Guide*
- 1 *Attention Windows 2000 Users* document
- 1 *Information Guide* (this document).

Known Limitations

The software and drivers CD-ROM contains applications that enable you to use your USB web camera on the Internet. The applications enable you to:

- create a web album
- create a web cam
- broadcast a live video.

These functions may not work if you are in a large office environment with a firewall and proxies. In this event, contact your network administrator.

The following functions will still operate:

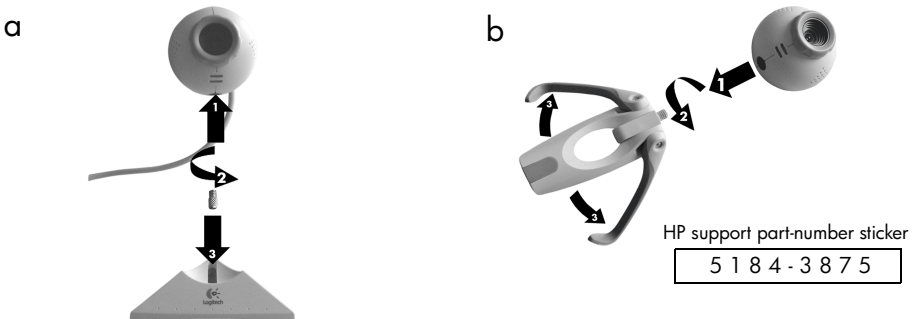
- Video and picture creation
- Video emails.

Assembling Your USB Camera

Two camera bases are supplied with your HP USB PC web camera.

The camera rest (a) is for use with CRT and some LCD monitors. HP recommend that you use the camera stand (b) with OmniBooks and most LCD monitors.

- 1 Assemble the camera eye and base as shown.
- 2 **Place the HP support part-number sticker on the rear of the USB camera eye.**



NOTE

The base or fixing clamp may look different on your model.

Using Your USB Camera

NOTE

Your HP USB web camera is supported on Windows 98 SE, Windows 2000 and Windows XP operating systems.

Windows 2000 users must read the *Attention Windows 2000 Users* document supplied in the kit.

Windows XP automatically detects your USB camera when it is first connected and uses the appropriate native driver. There is no need to use the CD-ROM provided.

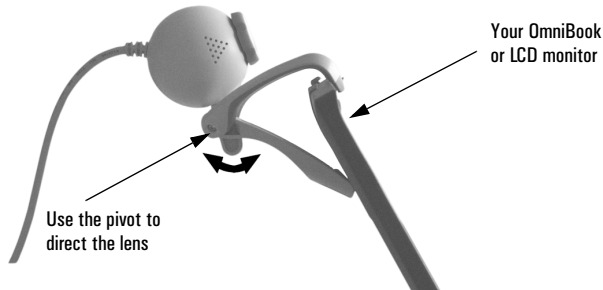
For software installation instructions, refer to the Logitech *Installation Guide*. Under Windows XP, not all features of your USB camera will be supported.

Positioning Your USB Camera

Refer to the Logitech *Installation Guide* for information on connecting your USB camera to your computer.

Once your computer has restarted, the Logitech QuickCamTest window will open. The window shows the view from your USB camera.

Make sure that your USB camera is positioned centrally on top of your monitor. If you are using your USB camera with the camera fixing clamp, place it on your OmniBook or LCD monitor as shown in the picture below:



If you are using your USB camera with the camera base, place it on your monitor with the Logitech logo on the camera rest facing you (see picture below). Direct the lens by tilting the camera eye upwards or downwards until the picture in the Logitech QuickCam Test window is satisfactory.



Adjusting the Focus

Turn the grey focus ring clockwise or anti-clockwise to sharpen or soften the focus until the picture in the Logitech QuickCam Test window is satisfactory.
